Fairy Fen on Bowen Island is now protected as the Islands Trust Fund newest nature reserve - The province of BC recently transferred the 18 hectare parcel of land to ITF through the provincial Free Crown Grant program. The new nature reserve protects a rare wetland ecosystem and undisturbed forested area. ITF and the Bowen Island Conservancy will consult the Bowen community about the area use including discussions regarding boardwalks and viewing platforms. Read more [here](#).

first group of Western Forest Products lands have been purchased by the CRD. 2,350 hectares of land are being purchased for a total cost of \$18.8 million, which will be paid in installments over three years. In the first installment, \$3.2 million will go towards watershed lands paid for in full by CRD Integrated Water Services. The balance will be paid through a 65-35% cost sharing agreement, with CRD Regional

Parks contributing \$4 million through its Land Acquisition Fund and its partners contributing the balance, including \$2 million from the provincial government and \$250,000 from TLC. For more info, visit [here](#).

Congratulations to the Salt Spring Island Conservancy's Stewards in Training program - they have won this year's Award of Recognition from the British Columbia School Superintendents Association. The program offers a hands-on ecological immersion experience to as many as 700 elementary and middle school children every year. Get the full story [here](#).

Columbia Basin Trust (CBT) is providing \$160,000 to support ecosystem restoration efforts in the Columbia Basin - With partners The Nature Trust of BC (TNT), The Land Conservancy (TLC) and the Nature Conservancy of Canada (NCC), three separate projects will restore plant and wildlife habitat on more than 170 hectares of Basin land. Draft Pacific Aquaculture Regulations Public Comment Period - In December the federal government takes over regulation of ocean based salmon farming from the province. Fisheries and Oceans Canada has drafted the new Pacific Aquaculture Regulations and sadly they fall short of providing any meaningful protection for wild salmon or the marine environment. BC Nature (Federation of BC Naturalists) has contributed \$70,000 towards TLC's Wild Hills and Beaches Campaign, to help purchase lands in the Jordan River, Sandcut Beach, and Sooke Hills area on Vancouver Island. The donation comes from a bequest to BC Nature from Lillian May Hayden. As specified in her will, the money is to be used for acquisition of land for nature on southern Vancouver Island. Nanaimo's Linley Valley is one of four tracts of coastal Douglas fir ecosystem on Vancouver Island now under a new land use order that will protect them from development. Pat Bell, minister responsible for the Integrated Land Management Bureau, made the announcement. In total, 1,598 hectares of the globally recognized high-priority ecosystem will enjoy increased protection after months of public consultation. Get the full story [here](#).

The Pacific Salmon Foundation and the Fraser Basin Council recently released their roster of 37 projects that are receiving more than \$1.8 million through their collaborative Fraser Salmon & Watersheds Program

(FSWP). The source of funds is the provincial Living Rivers Trust Fund and the federal Fisheries and Oceans Canada's Fraser Basin Initiative. In its fifth year of operations, FSWP aims to enable communities to steward their water and salmon resources by building collaboration, fostering leadership and increasing engagement. Information on the HST - Eligible registered charities and qualifying non-profit organizations will be able to claim a 50% rebate of the 5% federal portion of the HST (which replaces the GST in BC) and a 57% rebate of the 7% provincial portion of the HST. Learn more about rebates [here](#).
