**Ecosystem Restoration Website Launched** - The Rocky Mountain Trench Ecosystem Restoration Program has launched a website that makes hundreds of East Kootenay rangeland studies, reports, maps and air photos widely available for the first time. The project was made possible through support from Columbia Basin Trust's Environmental Initiatives Program. The websites online library contains over 300 current and historical documents—from a fragment of an 1894 map to 2010 reports—making it the most comprehensive collection of material gathered on East Kootenay grassland and open forest ecosystems. ### **Government of Canada's Consultation on Amending the List of Species under the Species at Risk Act: Terrestrial Species**

— As part of its strategy for protecting wildlife species at risk, the Government of Canada proclaimed the Species at Risk Act (SARA) on June 5, 2003. You are invited to submit comments on the potential impacts of amending the List of Wildlife Species at Risk according to these COSEWIC status assessments. Your comments will be considered and will inform the Minister's recommendation to Cabinet. Please provide remarks by February 4, 2011 for species under a normal consultation process and by February 4, 2012 for species under an extended consultation process. **Introducing the ActionH2O Water Sustainability Charter** - The POLIS Water Sustainability Project has developed a Water Sustainability Charter and WaterSmart Toolkit for communities across Canada. The charter aims to contribute to the global effort to mitigate our looming water crisis by providing a stepping-off point for the development of community water visions that

**Poll: Freshwater is BC's most precious resource** - Ninety-four percent of British Columbians say they want protection of nature, wildlife and species made a top priority in new provincial water rules, according to a poll released today. Nine in ten British Columbians say fresh water is our most precious resource. The McAllister Opinion Research poll, commissioned by the Vancouver Foundation and WWF-Canada, reports that nine in ten citizens, (91 percent) say fresh water is BC's most precious resource, while 86 per cent say fresh water is "extremely important" to the prosperity and quality of life in the province. **Opportunity to comment on a new water sustainability Act for BC** - The BC Government is exploring ways to modernize the Water Act to respond to the new challenges including dealing with population growth, land and resource development and climate change. A proposed new Water Sustainability Act is expected to be introduced into the legislature in 2012. **Ecovillage takes on green burial project: Rest in nature and Become part of the land** - The ability to scatter the ashes of your loved one is a green choice you may soon have in a serene spot close to home, according to Brandy Gallagher, OUR Ecovillage's outgoing executive director. The co-op is working on a project, which will include the availability of such a service on their 25-acre Shawnigan-area property. 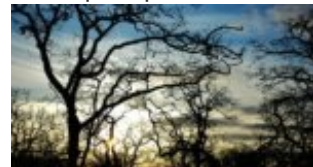
