The present version only has a hundred or so species in it, but more will be added over the next year. The site endeavours to present the best data sets used to monitor each species (e.g. Breeding Bird Survey, Christmas Bird Count, migration monitoring networks, etc.) and come up with a status of how each species has fared over the past 40 years. **New RDN park to open soon** - Nanoose Bay's Moorecroft lands have now been transferred over to the Regional District of Nanaimo and will become a regional park for the public to enjoy, but not quite yet. The RDN purchased the property from the B.C. Conference of the United Church of Canada for 4.8 million with a conservation covenant to protect over 90 per cent of the land base. The Nature Trust of BC is currently running a campaign to contribute up to \$500,000 to help with the acquisition and upgrade work that needs to be done. Get the full story [here](#).

**Kids give Carr's lily field a makeover** - Students at South Park Elementary have been doing more than planting trees in a corner of their Douglas Street schoolyard -they've been digging into the history of their James Bay community. With the help of workers from the City of Victoria and the Greater Victoria school district, and guidance from the Habitat Acquisition Trust, the students are creating a native species garden in an area known to have been favoured by one of James Bay's most famous residents -Emily Carr. Malaspina Land Conservancy Society (MLCS) has received a gift from a generous member who has pledged to sponsor the first 50 new members of the society for one year. The gift is provided to increase public recognition of MLCS and involve more people in its development. MLCS was formed to assist private land owners, whether individuals, industry or businesses, with decisions relating to the preservation and conservation of their land. "We do this by holding an interest in the land," said MLCS President Janet Alred. Working with the Victoria-based land trust, The Land Conservancy, as an agricultural program assistant, Nathalie Chambers is leading the just-launched Pollinator Enhancement Program. The provincewide plan aims to improve conditions for native bees so that farmers are not as dependent on the honeybee, the dominant pollinator, originating in the Mediterranean area and brought to B.C. in 1858. **A Gulf Island land conservancy has raised more than half the funds needed to purchase land for a unique long-stay, nature-study centre on Galiano Island** - The centre, a project of the Galiano Conservancy Association, will allow city kids from the Lower Mainland and Vancouver Island to connect with nature through multi-day learning programs. "We already have two million dollars in matching funds committed from the National Areas Conservation Program, contingent on our raising another two million," conservancy coordinator Ken Millard said. **North Pender family's land covenant protects wetlands, forests: Arthur Kikuchi was inspired by his father, a life-long naturalist** - A North Pender family has permanently protected their 1.78-hectare property's forest and wetlands with a conservation covenant. Owner and organic farmer Arthur Kikuchi moved to North Pender Island in 2000 because the landscape reminded him of Japan where he grew up, the Islands Trust noted in a news release. When Kikuchi received an inheritance in 2009 from his mother and father, a lifelong naturalist who specialized in the protection of wetlands and forest, he bought additional land on Pender to protect it in its natural state.
