## Funding Deadlines

**Wildlife Habitat Canada,**  
**November 1** - WHC offers grants supporting habitat conservation, restoration and enhancement of wetlands and waterfowl habitat.

**EcoAction Community Funding Program,**  
**November 1** - Environment Canada program encouraging action focused projects that will protect, rehabilitate or enhance the natural environment and address either clear air, clean water, climate change or improving natural habitat.

**HCTF Enhancement Projects,**  
**November 2** - The Habitat Conservation Trust Foundation supports projects that focus on freshwater fish, native wildlife species and their habitats; have the potential to achieve a significant conservation outcome; and maintain or enhance opportunities for fishing, hunting, trapping, wildlife viewing and associated outdoor recreational activities.

**Canadian Wildlife Federation is inspiring and supporting creative and critical hands-on learning through wildlife habitat projects**, like plantings focusing on native species. Educators can apply to certify a wide range of projects, like developing butterfly gardens, shelterbelts or duck nesting boxes. **The Garry Oak Ecosystems Recovery Team (GOERT) announced a four year contribution agreement with Parks Canada Agency** at their October Annual General Meeting. The Habitat Stewardship Program allocates funds to projects that conserve and protect species at risk and their habitats and help to preserve biodiversity. **TLC Works Behind the Scenes to Help Secure Malamute** - As a popular climbing destination and valuable falcon nesting bluff, the Malamute was recently protected and added to the Stawamus Chief Provincial Park. It was a multi-level initiative which involved the Province of BC, the District of Squamish, several First Nations, various climbing associations, and the landowner, Malamute Holdings Ltd. From the beginning TLC played a vital role in the land acquisition as the mediator. Read more [here](#).



**An innovative new initiative aims to better protect a stretch of the Fraser River, one of the most productive stretches of river anywhere in the world** - The growing pressures of urbanization, agricultural expansion, resource extraction, and land development are rapidly claiming the remains of this once extensive ecosystem. To counter this, a number of organizations such as the Nature Trust of British Columbia, the North Growth Foundation, the Rivers Institute at the British Columbia Institute of Technology (BCIT), the Pacific Fisheries Resource Conservation Council, and the BCIT Fish and Wildlife Program are leading an initiative to bring together political, corporate, and public interests to restore and protect what's left of these aquatic habitats and landscapes for future generations. **Two key resolutions initiated by the Islands Trust to protect the marine environment were endorsed** at the annual convention on September 30 attended by more than 1000 representatives of local government throughout BC. The Union of BC Municipalities (UBCM) endorsed both a resolution to deal with derelict vessels and another supporting a National Marine Conservation Area over the southern Strait of Georgia.
